RESEARCH METHODOLOGY

My research methodology has been essentially based on the following issues: 1) analysis of the available printed sources (diaries, letters, testimonies, memories, travel notes etc.); 2) integration and comparison of the collected data; 3) archival research, both in Western and Afro-Asian archives, mainly in western languages, which eased the discovery of rich documentations, in large part unpublished; 4) study of documentary sources (treaties, international acts, parliamentary papers); 5) direct knowledge of the populations and of the regions through field work research missions; use of oral traditions. This multidisciplinary and interdisciplinary approach allowed me to the fundamental analysis of the available written sources with direct experience of cultures, social and political traditional structures. The key instruments of reading, and/or re-reading are the product of the analysis of the historical-political events through a perspective which tends to be as much as possible exhaustive, updated and innovative. Moreover, the coordination of international research groups eased new abilities for the abovementioned methodological research issues.
